Chairperson Amato discussed fee for Board Members for liability insurance from Legion Insurance at a year rate of \$2,325 or a pre-paid fee of \$6,278. Board agreed to purchase insurance for liability insurance for Board Member. Chairman Amato made a motion to accept the liability insurance and buy the pre-paid 3 year policy, seconded by Floyd Jordan, all in favor, motion carried.

Secretary Jordan recommended to the Board that an annual breakdown of expenses be prepared by Steve Gordon, CPA for the fund. Secretary Jordan made a motion to accept a report be prepared, seconded by Chairperson Amato, all in favor, motion carried.

Chairperson Amato inquired to the members if there was any further business. There being no further business, Chairperson Lee Amato made a motion to adjourn, seconded by Mike Brady, all in favor, motion carried, meeting adjourned at 9:45 a.m.
