Lee Amato, Chairperson, called meeting to order at 8:12 a.m. and showed members present. Minutes from the April 27, 2005 meeting were reviewed by Board. Trustee Mayra Diaz-Buttacavoli advised the Board of one correction to the minutes, to remove Christina Cuervo's name listed under the "Absent Column." Trustee Robert Dowling made a motion to make this correction and accept the corrected minutes, seconded by Trustee Mayra Diaz-Buttacavoli, all in favor, motion carried.

Trustee Robert Dowling requested reimbursement of a registration fee expense he incurred for his attendance at the conference in Tallahassee in March, 2005. This request was deferred to the next quarterly meeting because it requires three votes and Trustee Dowling was disqualified from voting from a conflict of interest.

Trustee Mayra Diaz-Buttacavoli advised the Board members that Georgie Echert, Assistant Finance Director for the City, will be the contact person recommended by the City Manager for the State to correspond with regarding the list of property addresses. Trustee Mayra Diaz-Buttacavoli also discussed with the Board members that the database may be used for both Police and Fire Departments and both departments should meet to discuss combining the requested list of addresses for the State.

Henry Renard and Robert Maddock of Inverness Counsel discussed with the Board the financial aspects of the fund. See attached charts. Trustee Dowling discussed the pending financial reports from Inverness Counsel be done on a monthly basis to the Board. The Board agreed to a monthly report from Inverness Counsel.
